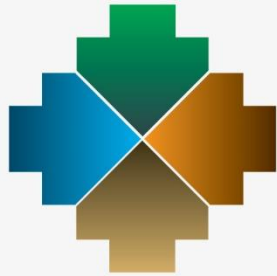

ENABLING THE PRIVATE SECTOR'S PARTICIPATION WITHIN THE MASTERPLAN FOR ASEAN CONNECTIVITY 2025 (MPAC 2025)

The Master Plan for ASEAN Connectivity 2025 (MPAC 2025) has been officially ratified by ASEAN heads of state this past September 6th 2016. As a result an annual G2B dialogue is now essential to provide a platform for wider ASEAN cooperation in facing the challenges for infrastructure development outlined within the plan, projected at USD 3.3 Trillion. Hosted by the Indonesian Chamber of Commerce (KADIN) in coordination with the Indonesian Government and the ASEAN Secretariat, the ASEAN G2B Infrastructure Investment Forum has been specifically designed to address critical challenges and opportunities for partnering with Indonesia in delivering over 1/3 of the projected spend (USD 1.3 Trillion) required across Indonesia as outlined within the MPAC 2025.



DELIVERING PROJECTS AND PARTNERSHIPS ACROSS INDONESIA'S CRITICAL NATIONAL INFRASTRUCTURE

RGC is the annual infrastructure forum that sets the stage to support the infrastructure agenda of the Indonesian Government. This year's RGC will examine projects and the opportunities for investment across Indonesia's rapidly expanding infrastructure sector. The core focus of the conference will be to examine how to address the urgent need for infrastructure upgrades and investment. It will review major projects across a wide variety of infrastructure streams, including roads, rail, ports and energy.



INNOVATION AND TECHNOLOGY IN CONSTRUCTION AS DRIVERS OF SECTOR GROWTH AND ECONOMIC DEVELOPMENT

IIW's Construction Conference is an ideal platform for sharing the latest ideas, reviewing technologies and learning about emerging trends in the fast growing construction sector. This year's conference will examine opportunities presented to the construction sector by the expansion of Indonesia's toll road network and the increasing adoption of smart construction technologies.

The broadband rollout currently being implemented across Indonesia, along with the delivery of 4G and 5G (from 2020) networks can be major enablers of increased smart technology usage.
